#### **About Us**

Developing Countries Research Centre (dcrc) was set up by the University of Delhi on 20th April 1993 under the Board of Interdisciplinary Program through Ordinance XV-A. The academic space so created soon became a hub for teachers, students and researchers engaged in researching developing societies of Asia, Africa and Latin America. The year 2004 was a historic moment in the life of dcrc. Vide Ordinance XX (9) it acquired the status of a constituent of the Faculty of Social Sciences, though it was formally inaugurated by Professor G. Ram Reddy, Chairperson, UGC, on 5 August 1994. It was supported by the UGC during initial years.

The Centre is obligated by the Ordinance to organize regularly Comparative theory seminar, annual grassroots politics colloquium in order to facilitate dialogue between scholars and activists, annual workshops on different issues related to human rights, and Oliver Tambo and Pablo Neruda lectures every alternate year.

In pursuit of its objectives, the Centre has organized seminars and conferences both at national and international level. At times it has organised events in collaboration with prestigious institutions such as the Nehru Memorial Museum and Library, AKUT Group of Uppsala University (Sweden), Max Mueller Bhavan, Centre for the Study of Developing Societies (CSDS), Aligarh Muslim University, International History Congress, V.V. Giri National Labour Institute, Central Social Welfare Board, Women's Studies and Development Centre, Planning Commission, Institute for Human Development, DESTIN of the London School of Economics and Political Science, DFID, Japan Foundation, Vidyajyoti and the constituent colleges of the University of Delhi.

The Centre aims to produce a body of knowledge that confronts and conceptualizes issues of the postcolonial world and encourages scholars to problematize them further. Scholars from across the board, such as Political Science, Economics, Sociology, History, Geography, Education, Philosophy, Psychology, Literature, Film and media studies have been involved in this effort. The main objective is to thematize knowledge so gained and critically engage students with such insights while teaching at the undergraduate and postgraduate level in the vast network of Delhi University. Above all, the objective is to build dcrc as a centre that can act as a springboard of critical and creative theory.

The Centre ensures criticality and creativity in its academic work by entailing two key things in the main. It structures its academic activity in a way that builds an interface between inputs gathered from academics and grass root activists, which turn out to be a critical laboratory of testifying knowledge for both, theory and practice. The other key aspect is that the Centre encourages scholars to adopt methods of academic engagement that rescue disorientations in knowledge production, which generally occur while studying developing societies from the dominant paradigms of the West. The larger endeavour is

to have an alternative world-view of how to look at issues related to culture, nationalism, gender, sexuality, religious minorities and other narratives.

The Centre acquired a new currency with Prof. Sunil K Choudhary at the helm of affairs as Director since July 2015. A Gold Medalist from the University of Delhi and recipient of several awards and accolades, including the very prestigious the 'Global South Award 2014', Prof. Choudhary has set examples of high moral standard and probity in academic and public life for Fellows of the Centre. As he rightly calls himself 'Pratham Sevak', Prof. Choudhary has been able to inculcate in all a spirit of togetherness, so characteristic of a 'Parivar'.

The Centre has six committees headed by fellow conveners. Some of the committees are: Purchase, Seminars/Conferences, Library, Website, Gender Sensitization and Printing/Publication. The Advisory Committee headed by Hon'ble Vice Chancellor is the apex decision making body of the Centre, while the Fellow Council and Research Committee are meant for discussing various issues of academic interest. All the fellows are members of these committees. The fellows and conveners meet regularly in their respective committees and contribute to the corporate life of the Centre.

The Fellow Council meets on the first working Friday of every month. The Fellow Council discussion is preceded by an academic discourse covering issues of contemporary relevance. For all research related decisions, the Centre has the Research Committee which meets quarterly to discuss, deliberate and decide on the research issues.

He is deeply involved in agricultural transformation and rural development, women empowerment, Panchyati raj Institution, geo-hazards earthquake & landslide, floods mapping (Micro-zonation) and database management for natural hazards. He has a Major Research Project for 10 Years on

'Ecological Restoration and Socio-economic Empowerment of Rural Communities for Sustainable Livelihood and Resource Management in Uttarakhand' covering 19 Villages and 14,000 population. He has written three books and published many articles in leading journals. He is national expert on training on CSR Policy. Popularly known as 'Project Man', Prof Kaushal has completed more than hundred research projects in different areas, particularly at the grassroots levels. He has also been instrumental in synergizing research projects with public policies and government programs engaging young students and scholars into various welare activities of the State. Combining academic and administrative qualities, he has been a source of inspiration to many students and scholars, social scientists and social activists in contemporary times.

#### Academic Activities and Programs at the Centre during 2020-21

The Centre organized various activities in the academic year 2020-21 which is an achievement in itself.

The Annual Report apart from providing an overview of the Centre, gives a glimpse of Centre's major activities in the previous year to its readers.

#### (a) Conferences, Seminars and Workshops


• An informal interaction in terms of a lecture was held with the Research Scholars associated with the Centre on 'Tandem Voting' on 17 May 2020. Speaking on the occasion, the Director of the Centre, Prof Sunil K Choudhary narrated the electoral journey of post-independence India with a focus on the simultaneous voting by the electorates for the Lok Sabha and assembly elections, called tandem voting.



Prof Sunil argued that the myth of tandem voting was largely broken with the beginning of the 21st century when the new and young voters started differentiating their preferences for the assembly and the national elections separately. He also questioned the increasing commercialization of the survey research by professional agencies where the focus had shifted from 'voters' to 'voting'. Participating in the discussion, the research scholars appreciated and acknowledged the contribution of the Centre in taking a great leap in the survey research for past three years.

• Amidst the lockdown for Corona and Covid-19, University of Delhi announced the holding of Open Book Examination (OBE) for all its final year students in Undergraduate and Post Graduate courses. As the Convener of the Examination Committee at the Department of Political Science and Nodal Officer for the discipline in the University, Prof Sunil K Choudhary not only facilitated in preparing the UG and PG question papers for OBE but also organized orientation workshops for the College Conveners and delivered lectures to students and teachers in the University. Defining open book as student-friendly system

where students remain the 'framers, finders and facilitators' of the examination, Prof Sunil urged the students and teachers to take up the new challenge of open book examination with a new spirit of adjustments, accommodation and accountability.



In all the OBE workshops, Prof Sunil sought to respond to the questions and queries raised by students and teachers across colleges.

• Taking the research from qualitative to quantitative domain, Prof Sunil organized a web interaction with the researchers and scholars under the platform of the Centre on 14 June 2020 with a theme, 'Quantifying the Research: C<sup>3</sup> Phenomenon'. Expressing his tribute to great Indian Mathematician



Nilakantha Somayaji for his 576th birth anniversary on the day, Prof Sunil elaborated on the theme by underlining communication, conceptualization and contextualization as the essential components of

research. Defining quantifying research in terms of quantum leaps and quantum jumps, Prof Sunil exposed the students with the salience of constants, variables and the interrelationship between the two in contemporary social science research.


The lucid presentation of the mathematical and statistical terms like regression, correlations, standard deviation and their extrapolation in research received great applause from the students and scholars alike.

• To facilitate the compilation of more than one lakh samples, a Workshop with all 14 Draft Writers along with the Draft Facilitators was held under the banner of Samiksha Delhi 2020 on 6 February 2020. Initiating the discussion, the Samiksha Draft Convenor and Coordinator, Fellow Dr Mahesh Kaushik requested all the draft writers to be objective, holistic and analytical in their writings. Samiksha Co-Coordinators, Dr Abhay Prasad Singh urged the fellow draft writers to be original in their writings so that their drafts should be matched with the competing global standards.



Appreciating the efforts of all the seven draft writing teams, the Director of the Centre, Prof Sunil K Choudhary highlighted the salience of draft writing amidst new concerns and challenges by stating that there should be linkages between history and contemporary realities.

• Under the banner of Samiksha series, the Centre organized a three-phase study of Assam and a sevenphase study of West Bengal assembly elections during March-April 2021. With the help of the postgraduate students of Political Science, University of Delhi along with various other colleges and universities of Assam and West Bengal, the Centre conducted its second online election study gauging the voting behaviour of the two states during the course of assembly election.



#### (b) Monthly Lectures

• With the onset of unlocking in the wake of Corona and Covid-19, the Centre organized its first Webinar on 'Colonial State, Indian History and Left' on 31 July 2020. Dr Himanshu Roy, a Senior Fellow at the Nehru Memorial Museum and Library, New Delhi was the keynote speaker. This was the first formal interaction of any resource person with the fellows at the Centre happened in the aftermath of Corona. Speaking on the occasion, Dr Himanshu Roy stated the tactical manoeuvrings of both the British Raj and the Indian Left in undermining the richness of Indian history, culture and civilization. Dr Himanshu Roy argued that the Indian Left, particularly CPI has been in decimation whereas the RSS has been on its acceleration by becoming one of the largest organizations of the world despite the two having the same birth year in 1925.



#### (c) Interactive Discourses


• On the occasion of Gandhi Jayanti, the Centre held an Interactive Discourse both online and offline inviting students and scholars, fallows and faculty. Speaking on the occasion, Dr Hari Ram Parihar and Dr

Dinesh Gehlot from Jodhpur, Rajasthan highlighted the salience of Gandhian values in contemporary times. Spearheading the Gandhian message with the motto, 'Clean India, Green India', a kindergarten student from Bal Bharati Public School, Brij Vihar, Ghaziabad, Uttar Pradesh, Myra Biswal displayed the Gandhian portrait and shared her rhymes on the occasion. The Director of the Centre, Prof Sunil K



Choudhary underlined the characteristics of Gandhian philosophy by projecting Gandhi as a 'Man of Action, Affection and Attention'.

• The Centre celebrated the birth anniversary of India's Iron Man, Sardar Vallabhbhai Patel on 31 October 2020 with the theme, 'Patel and Nation Building'. The program enlisted online and offline participation of students and scholars all across the capital and the country. Many young scholars and fellows of the Centre shared their ideas on the contributions of Sardar Patel in nation building. Highlighting Sardar Patel's distinct role through the IPC Approach with a focus on 'Integration, Persuasion and Coercion', Prof Sunil K Choudhary emphasized incredible contributions of Sardar in India's nation building mission.



#### (d) Webinar

On the occasion of Teacher's Day, the Centre organized a Webinar on Higher Education in New Education Policy: An Evaluation by Prof. A.S. Narang from IGNOU, New Delhi on 5 September 2020. On this auspicious occasion of Teacher's Day, three generations of students came together.

Mr. Devendra Kakkar, formerly associated with School of Open Learning and is a member of Advisory Committee of the Centre graced the occasion with his virtual presence. The event was started by release of its Newsletter, Sanchayan as well as the July 2020 issue of its Hindi Monthly Magazine, Sanshleshan, and followed by a profound talk by Prof A.S. Narang.

Prof Narang gave an elaborate account of the vision behind the new education policy along with the challenges of its implementation. He elucidated on how post-independence democracy and education were seen as the agents of change but have themselves become victims of socio- economic stigmas of corruption and casteism.



According to Prof Narang, the New Education Policy aimed at elucidating not only the changes that the policy envisioned but also laid down an elaborate method to achieve the aforesaid. By laying down its focus on inclusivity and equity to expand the outreach of education, the policy marked a shift from the British influence to the American influence. It also tended to increase the intake by opening new higher education, encourage private institutions to maintain basic minimum standards of quality education.

The policy aimed at adopting a new holistic education system that is rooted in our culture and civilization. It had thus put forth revolutionary changes that required sustenance on the ground by enabling infrastructure and consistent efforts, argued Prof Narang. The Webinar was concluded with a vote of thanks and an interactive session coordinated by Fellow, Dr Mahesh Kaushik.

#### (e) Third Atal Bihari Vajpayee Memorial Lecture

On the occasion of 96th birth anniversary of Shri Atal Bihari Vajpayee, the Centre organized the Third Atal Bihari Memorial Lecture on 25th December 2020. Held as a Webinar, the lecture was titled "Vikas Ki Bhartiya Aavdharna". The key note speaker of the event was Dr. Mahesh Chandra Sharma, President of Ekatmak Manavdarshan Anusandhan Avem Vikas Sansthan, Delhi. The session was inaugurated by our esteemed Pratham Sevak of DCRC Parivar, Prof. Sunil K. Choudhary by welcoming the key note speaker and other fellow audience.

Dr Mahesh Chandra Sharma elaborately defined the tenets of the developing countries and gave a holistic idea of development according to the Indian ethos. The conditions of developed, developing and underdeveloped was being defined by those countries who considered themselves ahead of others; thought the parameters were vague and lacked dimension, stated Dr Sharma. Dr Mahesh Chandra Sharma also talked about how Pandit Deen Dayal Upadhyaya brought forth the element of integral humanism and the quotient of happiness in the development discourse.

Dr Mahesh Chandra Sharma elucidated as how decentralisation and 'swadeshi' play a key role in the development of every individual which adds up to the development of a nation. He mentioned that 'berojgari' [unemployment] being a Persian word does not belong to the Devanagari script and thus economic democracy is of supreme importance and could not be compromised upon. Employment should not be generated but one should own the means of employment. 'Swadeshi' should be inculcated at all stages to make the process of development indigenous and self-sufficient.



The lecture was a very well researched and articulated by the keynote speaker. The Webinar was concluded with a vote of thanks by the Centre's Joint Director, Dr. Ramesh Bhardwaj and an interactive session coordinated by Dr Mahesh Kaushik, fellow DCRC.

#### (h) Miscellaneous Activities and Programs

#### (i) dcrc Samiksha

Under the banner of Samiksha series, the Centre organized a three-phase assembly election study of Bihar in November 2020. With the help of the post-graduate students of Political Science, University of Delhi along with various other colleges and universities of Bihar, the Centre conducted its first online election study gauging the voting behaviour of the state during the course of assembly election. Covering all 294 constituencies with its 9044 samples collected in both online and offline modes, the Centre projected the survey results on 7 November 2020.



Countering and contradicting all the pollsters and poll agencies who had predicted the formation of RJD led Mahagathbandhan, the Samiksha survey results of the Centre projected the formation of the BJP-JDU Government in the state. Much to the dismay of all, the election commission results also endorsed the survey results of the Centre. With a deviance of less than 3 per cent, the Samiksha Bihar 2020 proved to be a new milestone of the Centre in the domain of psephology.

#### (ii) Celebrating the Glorious Five Years of Pratham Sevak

The third quarter of the Centre was also a proud moment for the successful completion of five years of its Director, Prof Sunil K Choudhary. Celebrating the glorious five years of Pratham Sevak, the first servant of the Parivar, Prof Sunil acknowledged with gratitude the cooperation, commitment and conviction of all the members of the Parivar - Fellows and Faculty, Students and Scholars, Administration and Authorities for steering the journey towards new heights of academic horizons.



#### (iii)Teacher's Day Celebration

The Centre celebrated Teacher's Day on 5 September 2020 with all its students, scholars and fellows and faculty members. The period 2020-21 unfolded many achievements of the Centre, particularly the publications. It was in December 2020 that the Centre released the bound volumes of 1,03,731 samples of Samiksha: Delhi Assembly Election Survey, the 27th



and 28th volumes of Sanshleshan, the Hindi Monthly Magazine of the Centre and the unveiling of Sixth edition of Annual Event Brochure.

The Centre also released the first three issues of its blind peer review bi-annual journal, GlobaLense: A Journal of Social Science Research amidst the gracious presence of Prof Veena Kukreja, Head of the Department of Political Science, University of Delhi on 14 August 2020. Speaking on the occasion, Prof Kukreja appreciated the efforts of the Centre in working assiduously in different domains of academics and research publications and congratulated all the fellows and students associated with the Centre in this mission.
